All courses on this agenda are designed according to the standards as published in the NJ Register, Monday, July 17, 2006 (CITE 38 N.J.R. 3019), Vol. 38, #14, N.J.A.C. 5:87. The curriculum in each session is tailored by the NJPO Educational Committee and the instructors to meet the needs of NEW board members and EXPERIENCED members. Course outlines and instructors' credentials have been submitted to the Department of Community Affairs. NJPO is certified as a training organization to present these programs.
